Conditions of Membership

Guest's fee will be \$5.00 per day per person per day. No Charge for out of town guest. Guest are restricted to 5 visits per season. Numbers of guest per day are limited to 4. Fee or guest pass must be turned in the day of visit. Pool members can earn free guest passes by volunteer work or by buying \$100.00 worth of Food City certificates, available through Greg Locke (865) 584-8839. A volunteer sign up will be posted.

Party Fees will be a \$25.00 usage fee for 5-9 guests and \$50.00 usage fee for 10 or more guests plus \$5.00 per swimmer. Also a Red Cross certified life guard will be required at member's expense. No parties will be scheduled on Saturday, Sundays, or Holidays.

Property Loss: The applicant(s) understand that Timbercrest Recreation Club or board members are not responsible for personal lost, damaged, stolen, etc. while using Timbercrest Recreation Club, including parking lot.

Medical Treatment: The applicant(s) gives permission for Timbercrest Recreation Club board members or pool members to provide medical treatment, and to transport an emergency center for treatment. Also the applicant(s) consents to medical treatment deemed immediately necessary or advisable by a physician.
